

## DURHAM COUNTY


Durham County has a population of 334,500, an increase of 18% over the past decade. North Carolina's population increased by 9% over the past decade.


#### NC immigrant population over 850K

#### POPULATION INCREASE FOR STATE OF NORTH CAROLINA AND SELECTED CITIES 2010-2020








Age structure of U.S.-born vs. foreign-born, NC, 2021



#### Education varies by world region of origin


Educational attainment of NC immigrant population (age 25+) by world region of birth, 2021

North Carolina foreign-born residents by country of birth, 2021




#### The Majority of NC Immigrants Speak Spanish

Number of languages other than English spoken in homes of NC public school students by county, 2021






## Only 26% of NC Immigrants Do not Speak English Well or Very Well


Ability to speak English among NC foreign-born adults (18+), 2021



Hispanic spending power in North Carolina now exceeds \$25 billion in economic impact annually, according to a N.C. Bankers Association study. "People must understand that Hispanics are now distributed throughout our economy," says Jim Johnson, a veteran UNC Chapel Hill business professor who studies immigration. "The popular image of them is that they're concentrated in landscaping, agriculture, construction and those kinds of fields. #### Durham appoints first Latina to City Council

Javiera Caballero sat in the Durham City Hall Council Chambers, waiting. The next day, she would celebrate her 40th birthday, but a larger accomplishment awaited.

After a 5-1 vote among the council, Caballero took her oath of office on Jan. 16, becoming just the second sitting Latino-identified public official in all of North Carolina. The race, which started with 24 candidates, filled the vacated council seat by now-Mayor Steve Schewel. Immediately after, Caballero sat through her first meeting as a councilwoman.

"I have to say thank goodness for that snowstorm," Caballero said of the quick turnaround, noting the small buffer the winter wonderland created as she prepared for her new job.

Schewel explained the importance of ap-







Lakewood and Bethesda Elementary are considered <u>Title I schools</u>, meaning both schools receive federal funding to help low-income students academically excel. <u>At Lakewood Elementary</u>, over 50 percent of the student population is Hispanic, and at Bethesda, the Hispanic population is approximately 35 percent. Both schools started their dual-language programs in the 2019-20 school year <u>after the Durham school board voted to approve the program in April 2019</u>.



The teenager's death immediately sparked a confrontation between the hospital and the teenager's parents, who are deeply religious. Santillan's parents had demanded a second opinion before their daughter was taken off life support, a request hospital officials first offered and then withdrew, according to Kurt Dixon, the family's lawyer.

"The family was very distraught," Dixon said. "The family does not want to remove Jesica" from life support. As you might expect, Jesica's family . . . [is] devastated by this tragic turn of events."

#### **Group faults Durham schools' treatment of Latinos**

One of North Carolina's largest school districts is discriminating against Latino students and their parents by failing to provide them with adequate resources, according to a nationally known civil rights advocacy group threatening to file a federal complaint.

The school district also had only three Spanish language interpreters for more than 5,300 students whose primary language is Spanish. Under federal law, the school must provide these students and their families with access to interpreters and important school documents in a language they can understand. The district failed to comply with the law.






